

**Sweet Memory Flash mob by TORVA**  
**Official Rules**

**NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED.** Flash mob by TORVA (the "Promotion") begins at 9:00:01 AM Eastern Time ("ET") on April 15, 2023 and ends at 11:59:59 PM ET on May 31, 2023 (the "Promotion Period"). The Promotion contains a Contest. The computer clock of the Sponsor (defined below) is the official timekeeping device in the Promotion.

1. **ELIGIBILITY:** THE PROMOTION IS OPEN ONLY FOR USERS OF THE YOU TUBE AND INSTAGRAM SOCIAL MEDIA PLATFORMS.. **YT integration/ IG post the creator announces the conditions of the Flash mob by TORVA** (the "Contest") who are legal residents of the 50 United States and the District of Columbia, and who are 18 (except Alabama and Nebraska 19 and 21 in Mississippi) years of age or older as of date of entry.
